Departmental Reports

Item 1. Mayor Hrinya presented the Mayors monthly report. Motion made by Brian Buesink and seconded by Lu Inzana to change the Rec Board bylaws from a board of nine to a seven-man board with five from the borough and two from the township. Motion carried unanimously.
